KENYA

Community Concerns and Priorities in the Sondu–Miriu Dam Project

A petition was released on March 18th to the Japanese Foreign Minister, on behalf of community members affected by the Sondu–Miriu dam construction in Kenya. Japan has extensive financing and construction interests in the project. Concerns were expressed regarding Phase II funding for the construction of a power plant in the river Miriu. Key among the issues are the project’s negative impact on the environment, local economy, peace and security, corruption and human rights abuse (see annex 2) during the project implementation. Lastly, the petition urges the exercise of care and wisdom in your decisions. Most importantly, they would like your government to ensure that financing for this project is not used to trample on our rights and our environment, but used to alleviate our poverty as was originally intended. Mozambique

More than 40 NGO representatives and students participated in a seminar on Mozambique's Dams and Rivers that was organized by Livaningo and held in Maputo. Participants made presentations on a number of different dams in the country and discussed their impacts on rivers and the communities that depend on them. They focused specifically on the proposed Mepanda Uncua Dam and strategized on ways that the World Commission on Dams might assist civil society's involvement in decision-making processes related to the dam. A declaration drawn up at the meeting calls for the Mozambican government to adopt WCD guidelines as policy and to halt plans for proposed dams until it does so. The meeting concluded with songs and a river blessing at the mouth of the Incomati River.

NIGERIA

Communique Issued At The Public Lecture Organised By Society For Water & Public Health Protection (Swaphep) On March 14th, 2002 At Ken Saro-Wiwa Gallery, 214, Uselu • Lagos Road, Benin City, Nigeria.

Benin City, the capital of Edo State, Nigeria, was the center of a public lecture on Thursday, March 14th 2002 courtesy of Society for Water & Public Health Protection (SWAPHEP). The lecture was organized to mark this year's Day of Action against Dams, & for Water & Life.

The lecture which theme was •Dams & Development in Nigeria• drew participants from the academic society, NGOs, the civil society and the government. The participants did extensive discussions on the impact of dams on the process of development in Nigeria.

A number of questions were raised as to the rationale behind the continued construction of dams across the Nigerian watersheds despite the obvious devastating effects dams have had on the lives of Nigerians and their environment.

The participants were also particularly worried at the spate of dam failure in the country in the past two years, with mention made of the failure of Kainji dam in Niger State in 1999 and the failure of Tiga and Challawa dams in Kano and Jigawa states in August 2001 among others, and wondered at what government was doing to resettle the several thousands of the flood victims, payment of compensation to the relatives whose persons lost their lives to the flood and reparations to the

environment.

Participants also queried the reason why the management of the river basin authorities such as the Hadeja– Jama•are River Basin Authority would allow such a colossal loss of lives and property to preventable flood occasioned by dam failure and whether the country lacked the warning devices to forestall this gross waste of human and ecological resources.

Also of major worry to the participants was why Nigeria•s development partners such as the International Monetary Fund (IMF) and the World Bank continue to sponsor dams in Nigeria even when it is obvious that such huge amount of money don•t lead to the sustainable development of the country.

They also wondered as to the reason why the financial institutions don•t provide equivalent support and subsidies to alternative, clean and sustainable sources of energy and water supply.

The participants observed that, although, the use of dams as means of water supply, hydroelectricity generation, irrigation purposes, fisheries and so on, could not be completely ruled out, the immediate needs of the people for whom the dams are constructed must drive the process of dam construction and commissioning, a situation which is not the case in Nigeria. Before embarking on dams project, which are capital intensive and impact very negatively on the environment and the people, adequate expert studies and Impact Assessment Studies (EIA) reports, due consultations with and enlightenment of the communities that may be affected by the project must be done. These, the participants, noted were virtually absent in the case of Nigeria.

The participants were also agreed on the fact that political and economic benefits on the part of the government and the dam sponsors are the driving forces behind the continued construction of dams across our rivers and watersheds as the benefits derivable from the dams continue to elude the Nigerian people. Instead, epileptic power supply, inadequate water supply, destruction of farm lands, loss of fishes and other aquatic organisms and extreme poverty continue to plague the Nigerian people.

SOUTH AFRICA

Anti-Privatization, Anti-Eviction Campaign March, March 28th

The march will be held on March 28th to mobilize campaigners. The mass march is being organized by SAMWU, the anti-privatization forum and the anti-eviction campaign. It is pertinent that the mobilization is a big showing to bolster objectives. The march will be to protest the rising cost of basic services. The cost of water, electricity and housing is increasing; such that people have less money to spend on food and other basic commodities. The privatization of basic services by Multinational corporations is a growing concern; as cost-recovery and profits are the bottom line; with ill-regard to public services as a life-source. Basic services are being ring-fenced to "maximize efficiency and accountability" and the integration of complementary services is being ignored with the result that imperative issues such as health are being ignored, with the danger of compounding health-related issues e. g. Tuberculosis, HIV/AIDS and cholera (250 deaths in Kwa-Zulu Natal owing to water-cut-offs).

The argument put forward is to re-evaluate the present public-services system, prior to the forced introduction of commercialization and privatization of services. Increased public participation and consultation is core to our argument, whereby we find solutions together; solutions that maximize the accountability, provision and capacity of both the service-users and the providers.

Pumalanga event, HEALing Rivers

SAWaC (South African Water Crisis network) took part in the International Day of Action. SAWaC and HEAL (Houtbosloop Environment Action Link) a new local conservancy and community group, jointly hosted an event entitled '**HEALing Rivers**'. Several teams gathered at the lodge below the famous Sudwala Caves, in the Houtbosloop Valley of Mpumalanga Province on 14 March at 11 am. Each team, equipped with inflated tubes and rubbish bags, was allocated a section of the Houtbosloop down which they road in tubes, stopping to bag any rubbish they found on the way. The river has the highest drop over the shortest distance of any in the country, from its source in the pass above Lydenburg until it flows into the Crocodile.

In the afternoon there was a mini-workshop on river ecology and problems posed by dams. Among the speakers were Dr. Johan Engelbrecht of Mpumalanga Parks Board, on Integrated River Ecology, and Naomi Fourie of the Department of Water Affairs and Forestry on the Impact of Small Dams. Day of Action posters, stickers and flyers – both local ones by SAWaC and HEAL, and from the International Rivers Network in California, were distributed to help promote the worldwide event.

BOSNIA–Herzegovina

Protect rivers of Bosnia and Herzegovina (FONDEKO)

The meeting consisted of 600 pupils and 400 citizens to mark the occasion of the World Day of Water (held 21.03.2002). In Stari Grad (Old Town) Municipality, attendants expressed their concern against individuals and firms polluting the rivers Moscanica, Zeljeznica, Miljacka and Bosna; along with wells. Citizens and pupils called for the prohibition of the use of drinking water for washing cars and pavement. They further requested access for all inhabitants of Sarajevo to safe drinking water and sanitation. Participants understand that all members of international organizations living in Bosnia–Herzegovina are supplied with bottled water from other European countries and therefore questioned the authorities to inform the citizens of potential threats to water supplies and drinking water quality.

Additionally, participants expressed full support of the citizens of town of Konjic and others for their request to halt the construction of a hydroelectric power plant on the upper reaches of the River Neretva.

Restore the Salzach River Dam Decommissioning Bicycle Tour

A bicycle tour was held along the banks of the Salzach River to visit a place where the side dams of the Salzach have been removed as an experiment to let the river flow into the riparian forest, a frequent occurrence before the dam. The Salzach River is a tributary of the Inn River which is a tributary of the Danube. The lower Salzach is one of the last few undammed rivers on the north side of the Alps. Although it is undammed it has been channeled with side-dams, which have stopped the frequent flooding of the riparian forests of the Salzach valley which is important for the survival of this eco-system. Organizers urged government agencies in Germany and Austria to restore the Salzach river in order to protect the riparian forest with its rich variety of species.

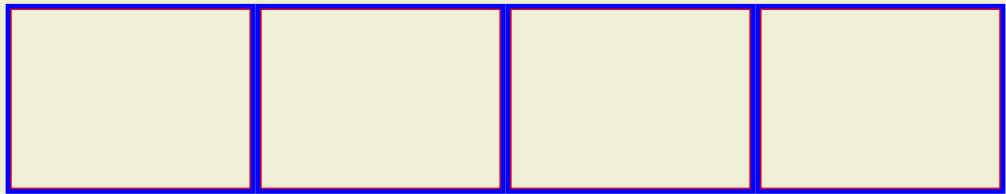

On Sunday March 10, 2002, members of " La Plataforma en defensa de l'Elbre"; academics ; political parties and unions demonstrated in Barcelona against the NHP (Watertransfer, 118 dams). Between 400.000 and 500.000 participants and Delegations from different areas of Spain were in Barcelona to voice their disagreement. This demonstration was planned right before the 14th of March, the worldwide day against dams and the 15th and 16th of March, the European Summit of the 15 EU environmental ministers in Barcelona. A delegation of ERN (European Rivers Network) visited with green Euro-Deputys and the Leaders of the "Plataforma" (Organizers) the Ebro Delta, participated at the demonstration and was very warmly welcomed.

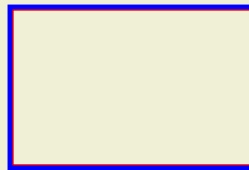

Despite the extensive water reserves in the Madrid region recently, irresponsible and wasteful management of water by the regional administration has given rise to a critical situation for the future water supply and for the rivers of Madrid. At present, owing to the regulation of the dams of the Jarama Basin, the water level of all the rivers is alarmingly low, running the risk that in the coming months many of them will dry out. *Plataforma Jarama Vivo* has published various materials about the situation for public information, and a motion was put forward by different councils demanding a change in the policies regarding water in Madrid. The motion also called for a system of ecological volumes of water for the rivers to be put into effect with regards to the dams of the region.

To mark March 14, civil society announced its opposition to the social and environmental impacts of large dams in Argentina. The foundation "Proteger" produced posters and materials on the International Day of Action to help promote the day through radio and television outlets.

In the Arist•bulo del Valle, the Ecological Group "Pir• Wedge", a member of the Network of Ecological Associations of Missions (IT ABRADES), organized a march of bicycles through the main avenues, ending in the Municipality, where a statement was given to the authorities. The supervisor of the city is against the Hydroelectric Project Corpus Christi, adding itself to 90% of the missionaries.*

"The river is much more than water that runs and does not have of being considered to only generate energy," Raul Bregagnolo said, leader of Cu•• Pir•. "the builders of great dams have led to the collapse of many rivers of the world and are doing the same in the Silver River basin, with hydroelectric works like Yacyret•, that demonstrate their unsustainability due to the tremendous social impacts, environmental, sanitary and economic. These damages were not considered, nor mattered to think about the development of the populations. The energy production was solely examined, . . . hiding that these great works always have caused poverty where they settle," emphasized Bregagnolo.*

"This 14 of March, more people will understand the importance of our rivers for a truly sustainable human development". On the other hand, the ecological group "Green Thought", of Resistance, Chaco, in a press note recalled "the national and provincial authorities that have responsibility for the life and the health of the town are unfinished with their mandate and they are guilty to future generations for the damages that undergo the communities by their actions or omissions". "the rivers have been and are life source. Their destruction and contamination have only as a consequence the death in the long-term and, with certainty, the present poverty ", expressed Baigorri Basoue, in March 14 declarations.*

Proteger has helped organize other activities.

Brazilian Movement of Dam–Affected People (MAB)

Marking the International Day of Action, events and marches were carried out throughout Brazil.

On March 12th, four anti–dam activists of the Brazilian Movement of Dam–Affected People (MAB) were hospitalized in Esmeralda, Rio Grande do Sul state after being shot with rubber bullets by a shock troop of the military police during a protest against Barra Grande dam (Uruguay River). Injured were two MAB leaders, Geni Andriolli and Lico da Costa, along with two Franciscan brothers, Frei Zanatta e Frei S•rgio G•rgen, who were among the 500 marching to the dam worksite.

MAB led a march of several hundred people, many of them affected by the Castanh•o dam, in Fortaleza, site of the Inter–American Development Bank's (IDB) annual meeting. A crucial issue is the IDB's financing of the Cana Brava dam (Tocantins River). According to MAB, 2,000 people affected by the dam, constructed by a Brazilian consortium in partnership with Alcoa, have not received compensation from Tractebel, a subsidiary of Suez (France). According to H•lio Meca of the MAB National Coordination, "Many families who lived in the area for 30 years or more received the miserable indemnification of R\$ 36.00 (equivalent of USD\$22) and small businessmen, who lost their business as their customers were expelled by the artificial lakes were not compensated".

On March 13th, MAB occupied the headquarters of the State Environmental Foundation of Minas Gerais state in the city of Belo Horizonte. 300 dam–affected people say they plan to remain in the office until they are granted an audience with the governor of the state to discuss problems caused by dam construction.

MAB's activities for the Day of Action are concentrated in Brazilian state capitals, including Porto Alegre, S•o Paulo, Rio de Janeiro, Belo Horizonte, Salvador, Cuiab•, Palmas, Fortaleza, and Florian•polis, and to the nation's capital Bras•lia where MAB plans to meet with government officials. Other actions are planned for Chapec•, Santa Catarina, and at Barra Grande dam, as well as in Altamira, Par•, a region which is threatened by Belo Monte dam (Xingu River).

On March 13th in Porto Alegre, a shock troop of military police advanced on 400 dam–affected people who attempted to participate in a public consultation on energy rates being held by the National Electrical Energy Agency (ANEEL). Various protesters were beaten, and five were hospitalized.

In Bahia state, 450 farmers threatened by Sacos, Gatos, and Cocos dams in Bahia set up a camp and plan a march through the streets of Salvador tomorrow.

600 farmers affected by Manso dam in Mato Grosso state are camped out in front of the palace of the governor. They are protesting inadequate resettlement conditions, and the fact that at least 600 families have still not received compensation. Besides, they say that more than 2,000 fishermen have lost their livelihood as a result of the dam. They expect to meet today with the state governor.

In Rio de Janeiro state, 300 people threatened by the Itaocara dam arrived today at

the state capital, where they will march to the governor's palace to meet with the state governor. Following this, they plan to march to the offices of several dam companies. In S•o Paulo state, 600 "quilombolas", or members of communities of descendents of escaped African slaves, will gather tomorrow in front of the state Justice secretariat to demand the cancellation of dam projects in the region of the Ribeira valley, and the titling of their lands. They plan to meet with the Vice–governor of the state.

400 dam–affected people marched through the streets of Chapec•, Santa Catarina state, and met with the company building the Foz de Chapec• dam on the Uruguay River. Another meeting has been scheduled for Friday.

In Bras•lia, leaders of MAB will meet with federal government officials, including the Minister of National Integration, the officials of the Mines and Energy Ministry, the President's Civil Cabinet, the National Agency of Electrical Energy, and the Agrarian Development Ministry.

HONDURAS

Indigenous Hondurans Mark The International Day of Action With A Cultural Exchange Between Dam–Affected Communities

On March 14, 2002, members of indigenous Lenca communities of eastern Honduras who are being threatened by a dam project celebrated the International Day of Action Against Dams by holding a cultural and informational exchange with visiting members of the Maya Achi people of Guatemala, whose own community of Rio Negro was devastated by a dam built in their region during the 1980s. The event will take place in the Lenca village of San Antonio, a traditional settlement that will disappear entirely under water if the proposed mega–dam El Tigre is built on the nearby Lempa River.

The goal of the event is to provide a forum for exchange between two indigenous communities facing similar problems. The visiting delegation of 7 Maya Achi people will have a chance to share their horrific experience of displacement and massacres due to the building of the Chixul dam, beginning in 1980 — experiences they have recently begun to share with the world in order to prevent similar events elsewhere. Meanwhile, their presence will help strengthen the on–going opposition of members of the Lenca population of the Lempa Valley to the El Tigre dam project, which would see them displaced and traditional lands flooded.

Event organizers COPINH (Civic Council of Popular and Indigenous Organizations of Honduras) hope the exchange sends a strong message internationally that indigenous people are informed and opposed to dam projects which displace and damage without consultation with indigenous land owners.

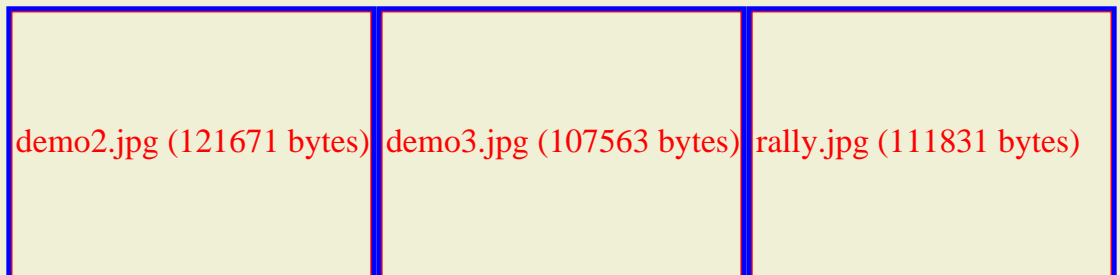
