IN 2014, WE WON AN 8-YEAR CAMPAIGN TO STOP FIVE DAMS ON TWO RIVERS IN CHILEAN PATAGONIA WHEN ENVIRONMENTAL PERMITS WERE CANCELLED. WE HELPED THE MAYA ACHI PEOPLE OF GUATEMALA WIN \$155 MILLION IN REPARATIONS FOR MASSACRES AND RESETTLEMENT CAUSED BY THE CHIXOY DAM IN THE 1980S. WE HELD WORKSHOPS IN INDIA, VIETNAM AND BURMA TO EDUCATE PEOPLE ABOUT MICROHYDRO POTENTIAL AND INTEGRATED RESOURCES PLANNING. TO HOLD FINANCIERS LIKE THE WORLD BANK ACCOUNTABLE, WE WON A HUGE VICTORY WHEN THE US CONGRESS REQUIRED THE TREASURY TO OPPOSE LOANS FOR LARGE DAMS FINANCED BY INTERNATIONAL FINANCIAL INSTITUTIONS, AND CALLED FOR JUSTICE FOR VICTIMS OF HUMAN RIGHTS ABUSES FROM THEIR PROJECTS.
